1. Players have to register his/her name on GBA official website <u>https://www.gujaratbadminton.org</u> (Player Sign up / Sign in) to generate GBA ID. GBA ID is a must otherwise your entry will not be accepted by website. Please fill all the particulars as required (Name and Surname) only.

In case of less than 6 six entries in any particular event in that case selection trial will take place.

- 2. You are requested to pay Entry Fee ONLINE. Otherwise your Entry will not be registered or accepted as we have arranged to collect the Entry and Entry Fees ONLINE.
- 3. Only those who intend to participate will register ONLINE as fee paid ONLINE shall not be refunded. Remittance of fee in consultation of each other is advised to the participants of the Doubles Events.
- Entries have to be sent online in the entry form available on the GBA official website, <u>https://www.gujaratbadminton.org</u> only. Last date of sending your Entry/ies is <u>29th January</u> <u>2025</u> up to 08:00 PM.
- Last date for withdrawals <u>31st January 2025</u> up to 10:00 AM. The withdrawal request must be sent to <u>entry@gujaratbadminton.org</u> only.
- 6. It is the responsibility of players to ensure that all the entries forwarded by them appear in the Main Draw List. - 7. Misbehaviour/misconduct with participant/s, Technical Officials, organizers, etc. by players, coaches, parents, etc. shall not be allowed. Strict disciplinary action may be taken against them by Referee and/or GBA.
- 8. **Dress code for the participants:** It is recommended that the name of the player should be printed on the back side of T-shirt as per the norms of BAI. Pasting of paper, sticker writing with marker pen, etc. are not allowed. Only printing is permissible on T-shirt. In pair events, both players should wear the same color of kitting.

- 9. The tournament is open only to all the **bonafide players of Gujarat State** and will be played as per BAI & GBA laws, rules and regulations.
- 10. All the matches will be of best of <u>Three Games of 15 Points with extension up to 21</u> points.
- 11. Complaint, if any, must be lodged promptly in writing to the Referee. The non-refundable fee per complaint is Rs. 500/- Please keep the copy of the complaint, duly signed by the Referee and the receipt of the payment for follow-up is required. The decision of the Tournament Committee will be final in all matters of disputes.
- 12. Players must report to the Referee 30 minutes before to their schedule match.
- 13. The morning session will normally start at 08:00 am and matches will be played throughout the day, till the schedule of respective date is completed, as finalized by the Referee. The matches may have to be re-scheduled in case of the situation/s beyond control.
- 14. Players may have to play 2 or more matches in the same session. The minimum interval of 30 minutes between two matches will be allowed to the player/s.
- 15. The schedule of the matches on all dav will be displayed on https://www.tournamentsoftware.com & at the venue notice board and players will adhere to it, failing which, they are liable to be given a walkover. Players should be prepared to play at a different venue/s if required.
- 16. Lodging & boarding will not be provided to players by the organizers. Accordingly, they will have to make their own arrangements for the same.
- 17. The prize distribution ceremony in respect of events should be arranged on the same day of its conclusion. Receiving prizes by the respective player/s is mandatory. Failing which, the respective player/s shall not be awarded the prize money.
