- 3. Only those who intend to participate will register ONLINE as fee paid ONLINE shall not be refunded. Remittance of fee in consultation of each other is advised to the participants of the Doubles Events.
- Entries have to be sent online in the entry form available on the GBA official website, <u>https://www.gujaratbadminton.org</u> only. Last date of sending your Entry/ies is <u>04th July 2024</u> up to 08:00 PM.
- 5. Last date for withdrawals <u>06th July 2024</u> up to 10:00 AM. The withdrawal request must be sent to <u>gbastdesai@yahoo.in</u> only.
- 6. The list of participants will be displayed on <u>https://www.gujaratbadminton.org</u> & <u>https://www.tournamentsoftware.com</u>. It is the responsibility of players to ensure that all the entries forwarded by them appear in the M&Q (Main & Qualifying) List. After the last date for withdrawals without penalty, no complaints shall be entertained for miss out of any entry/ies. GBA or organizers will not be responsible for any discrepancy/omissions of names thereafter.
- 7. Misbehaviour/misconduct with participant/s, Technical Officials, organizers, etc. by players, coaches, parents, etc. shall not be allowed. Strict disciplinary action may be taken against them by Referee and/or GBA.
- 8. The Qualifying draws of all GBA tournaments will be held at the GBA office through the Tournament Planner software. **The Main Draw will be held by open draw system** as per national tournaments during qualifying round matches, at the respective tournament venue, in presence of Organizing Committee, participants, etc. through the Tournament Planner software.
- 9. **Dress code for the participants:** It is recommended that the name of the player should be printed on the back side of T-shirt as per the norms of BAI. Pasting of paper, sticker writing with marker pen, etc. are not allowed. Only printing is permissible on T-shirt. In pair events, both players should wear the same color of kitting. All the players of main draws are advised to strictly follow it. The Referee can use his/her discretionary power regarding the dress code.
- 10. After the draw is published any player who withdraws her/his entry or gives a walkover, that player will have to pay a fine of Rs. 500/- without which that player will not be allowed to play in any of the future GBA tournaments.

- 11. Each participant should send her/his entry personally. Please do not send DUPLICATE entries as they are liable to be rejected.
- 12. In case of Doubles, partner's name is mandatory and has to be mentioned in the entry form; otherwise entry will not be accepted.
- 13. The tournament is open only to all the **bonafide players of Gujarat State** and will be played as per BAI & GBA laws, rules and regulations.
- 14. All the matches for Qualifying rounds, the matches will be of best of <u>Three Games</u> of <u>15 Points without setting</u>.
- 15. The main draw, the matches will be of best of three games of 21 points with setting.
- 16. Complaint, if any, must be lodged promptly in writing to the Referee. The nonrefundable fee per complaint is Rs. 500/- Please keep the copy of the complaint, duly signed by the Referee and the receipt of the payment for follow-up is required. The decision of the Tournament Committee will be final in all matters of disputes.
- 17. Players must report to the Referee 30 minutes before to their schedule match.
- 18. The morning session will normally start at 8.00 am and matches will be played throughout the day, till the schedule of respective date is completed, as finalized by the Referee. The matches may have to be re-scheduled in case of the situation/s beyond control.
- 19. Players may have to play 2 or more matches in the same session. The minimum interval of 30 minutes between two matches will be allowed to the player/s.
- 20. If required, players will have to officiate as Line Judges as advised by the Referee, which is mandatory.
- 21. The schedule of the matches on all day will be displayed on https://www.tournamentsoftware.com & at the venue notice board and players will adhere to it, failing which, they are liable to be given a walkover. Players should be prepared to play at a different venue/s if required.
- 22. Lodging & boarding will not be provided to players by the organizers. Accordingly, they will have to make their own arrangements for the same.
- 23. Food/beverages are not allowed inside the stadium. Please observe cleanliness in and around the stadium.
